## Opinion

We have audited the accompanying statement of audited financial results of **Capsave Finance Private Limited** (the "Company") for the quarter ended March 31, 2024 and year to date from April 1, 2023 to March 31, 2024 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 52(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
